

**CITY OF CLARKSVILLE  
CITY COUNCIL DEPARTMENT MEETING  
APRIL 15, 2013**

The Clarksville City Council met in regular session April 15, 2013, in the Council Chambers at 7:00 p.m. with Mayor David Kelm in the chair and Council members, Cathy Cummings, Jeff Kolb, and Diane Renning present, Mike Miller and Val Swinton absent.

The following Department Heads were in attendance: Kristen Clark, Library Director; Dan Cummings, Police Chief; Matt Kampman, Grounds Maintenance; and Larry Betts, Financial Administration.

Motion Renning, Cummings, to approve the monthly Library reports submitted by Kristen Clark.

Motion Renning, Cummings, to approve the election of officers for the Clarksville Fire Department: Fire Chief - Jon Myers, Assistant Chief – Matt Behrends, Captain – Joe Hinders, Lieutenant – Darren Spree, Secretary – Eric Wood, and Treasurer – Jeff Kolb.

Mayor Kelm administered the Oath of Office to Fire Chief Jon Myers.

Motion Renning, Cummings, to approve April expenditures as presented by the City Clerk.

Motion Kolb, Renning, to approve extending an order to abate nuisance to LeRoy Klinghammer, 503 S. Adams, Clarksville, until June 1, 2013.

Motion Kolb, Renning, to approve application for a special permit to Fred Backer at 703 S. Mather, for waiving Section 155.06 (2) size of accessory building to construct a building more than 1,000 square feet, pending there is no more than two accessory buildings or structures on residential property.

Motion Renning, Kolb, to adopt Resolution 13-530: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLARKSVILLE, IOWA, TO APPROVE AMENDING GARBAGE RATES.

BE IT RESOLVED by the Council of the City of Clarksville, Iowa:

1. In accordance with Section 106.08 of the City Code, that the following monthly fees be amended:

A. Refuse collection with curb-side recycling for residences be set at:

35 gallon cart \$19.40

64 gallon cart \$24.40

96 gallon cart \$30.40

Official bags \$1.75 each

B. Refuse Disposal fee to Commercial Establishments be set at:

Base rate for Disposal Fee Service: \$8.00

Commercial Establishment with:

(1) Dumpster/once weekly pick up - Base rate plus \$7.00 = \$15.00

(2) Dumpster/twice weekly pick up - Base rate plus \$14.00 = \$22.00

(3) Dumpsters/once weekly pick up - Base rate plus \$14.00 = \$22.00

(4) or more Dumpsters/twice weekly pick up - Base rate plus \$21.00 = \$29.00

C. All Commercial Establishment collection fees are set by services received from approved contracted refuse company.

2. All fees based on six (6) months annual occupancy.

3. Such fees shall be effective May 1, 2013.

4. This resolution shall remain in full force and effect until amended by the City Council.
