1. The following sentence shall be added to Section II. – DEFINITIONS 2.5 EMPLOYEES: “PERMANENT PART-TIME. Any employee working less than 35 hours per week on a permanent part-time scheduled basis.
2. The following sentence shall be added to Section XII. – BENEFITS of the City Personnel Policy: “Permanent Part-time shall be eligible for Health Insurance Coverage.”
3. This resolution shall become effective upon passage.
