

**CITY OF CLARKSVILLE
CITY COUNCIL BUSINESS MEETING
MAY 6, 2013**

The Clarksville City Council met in regular session May 6, 2013, in the Council Chambers of City Hall at 7:00 p.m. with Mayor David Kelm in the chair and Council members Cathy Cummings, Mike Miller, Diane Renning, and Val Swinton present, Jeff Kolb absent.

Mayor Kelm opened the Public Hearing at 7:00 p.m., for the purpose of amending the Current City Budget for the fiscal year ending June 30, 2013. There being no oral or written comments for and against the proposed budget amendment, the Mayor declared the hearing closed.

Motion Renning, Swinton, to adopt Resolution 13-535: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLARKSVILLE, IOWA, AMENDING THE CURRENT BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2013, AS AMENDED LAST ON MARCH 5, 2012.

BE IT RESOLVED, by the City Council of the City of Clarksville, Iowa:

1. Following notice published April 25, 2013, and the public hearing held May 6, 2013, the current budget (as previously amended) is amended as set out and in the detail by fund type and activity that supports this resolution which was considered at that hearing.

Motion Cummings, Renning, to approve application for a special permit to Fred Backer at 703 S. Mather, for waiving Section 155.06 (3D) front yard setback for the construction of an accessory building.

Motion Swinton, Cummings, to adopt the first reading of Ordinance No. 561: TITLE: AN ORDINANCE AMENDING RESTRICTED RESIDENCE DISTRICT.

Section I. Chapter 155, RESTRICTED RESIDENCE DISTRICT, Section 155.06 (2) is amended by adding item C:


“C. Accessory Building Materials. No detached accessory building walls or roofs shall be constructed of any type of fabric, plastic, vinyl, or fibrous materials.”

Section II. This ordinance shall become effective upon passage of the City Council and after publication.
