

**CITY OF CLARKSVILLE
CITY COUNCIL BUSINESS MEETING
JUNE 2, 2014**

The Clarksville City Council met in regular session June 2, 2014, in the Council Chambers of City Hall at 7:00 p.m. with Mayor David Kelm in the chair and Council members Cathy Cummings, Jeff Kolb, Diane Renning, Travis Sterken, and Val Swinton present.

Motion Sterken, Renning, to approve and adopt the items contained on the Consent Agenda: Motion to approve minutes (May 5, 2014 and May 19, 2014); and financial reports.

RCV – Ayes: Cummings, Kolb, Renning, Sterken, Swinton. Nays: None. MC.

Motion Kolb, Swinton, to approve applications for cigarette permits to K & S Grocery, Express Mart, and Casey's General Store.

RCV – Ayes: Cummings, Kolb, Renning, Sterken, Swinton. Nays: None. MC.

Motion Renning, Cummings, to adopt Resolution 14-551:

WHEREAS, the Des Moines Register's Annual Great Bicycle Ride Across Iowa will arrive in Clarksville on July 24, 2014; and,

WHEREAS, the RAGBRAI event will draw approximately 10,000 people to Clarksville on that date; and,

WHEREAS, the arrival of 10,000 people in Clarksville will cause public safety and health related problems;

NOW THEREFORE, it is the Resolution of the City of Clarksville that the following Resolution is hereby enacted:

SHORT TITLE:

RAGBRAI RESOLUTION

Section 1. **RAGBRAI COMMITTEE**. The City Council is officially appointing the 2014 RAGBRAI COMMITTEE.

Section 2. **FOOD VENDOR**. No person shall provide or sell food/beverages to the public in Clarksville on July 24, 2014, unless the person has first obtained a Vendor's Permit from the RAGBRAI COMMITTEE.

However, see Section 8.

Section 3. **FOOD VENDOR FEES**. The fee for a Food Vendor's Permit shall be \$250.00 for out of town vendors.

The Food Vendor Permit shall be granted on condition that the Food Vendor locates his sale stand at a location to be determined by the RAGBRAI Committee; and, all food vendors must show proof of liability insurance in an amount to be approved by the RAGBRAI Committee; and, all food vendors shall comply with the Iowa Department of Health Rules and Regulations governing the sale of food for consumption on the premises.

Section 4. **STREET VENDOR**. No person shall sell merchandise/entertainment to the public of Clarksville on July 24, 2014, unless the person has first obtained a Vendor's Permit from the RAGBRAI COMMITTEE.

Section 5. **TEMPORARY STAND**. Temporary stand for the sale of food or other merchandise shall be permitted at locations designated by the RAGBRAI COMMITTEE.

Section 6. **NUISANCE**. The sale of food/beverages or the location of a temporary stand for the sale of food/beverages or merchandise/entertainment outdoors without a permit or in violation of any of the provisions of this Resolution is hereby declared to be a nuisance. The policemen of the City of Clarksville are hereby empowered to cause any offending stand or temporary stand or outdoor entertainment or place to be dismantled and removed without notice.

Section 7. **MISDEMEANOR**. It shall be a misdemeanor for any person to supply or sell food/beverages/merchandise/entertainment within the City of Clarksville on July 24, 2014, without first having obtained the appropriate Vendor Permit.

It shall be a misdemeanor for any person to violate any of the provisions of this Resolution.

Section 8. **EXCEPTION**. It shall not be a violation of this Resolution and no Vendor Permit shall be required for a person to sell or supply food/beverages in Clarksville on July 24, 2014, on his licensed premises providing that the person was in possession of a current Iowa Permit for the sale of food/beverages consumption on the premises as of July 1, 2014.

Section 9. **SUPPORT**. In as much as all of RAGBRAI support is from 12:00 p.m. (noon) to 5:00 p.m., it is the direction of the City Council that the RAGBRAI Committee will post the appropriate time riders would need to leave Clarksville to arrive in Waverly by 6:00 p.m. And required all activities to completely cease at 5:00 p.m.


