

**CITY OF CLARKSVILLE
CITY COUNCIL DEPARTMENT MEETING
JANUARY 20, 2014**

The Clarksville City Council met in regular session January 20, 2014, in the Council Chambers at 7:00 p.m. with Mayor David Kelm in the chair and Council members Cathy Cummings, Jeff Kolb, Travis Sterken, and Val Swinton present, Diane Renning absent.

The following Department Heads were in attendance: Kristen Clark, Library Director; Dan Cummings, Police Chief; Matt Kampman, Maintenance Superintendent; and Larry Betts, Financial Administration.

The City Council received requests from all Department Heads for the 2014/15 City Budget.

Jim Mendez, representing Waste Management, went over garbage and recycling pickup services for the City. He noted that stickers would be replacing the yellow (over flow) bags soon; also they will be providing 96 gallon containers for recycling. Jim said that as long as garbage containers were out at the curb by 5:00 a.m. on Mondays, residents will not be missed for pickup.

BE IT RESOLVED, by the City Council of the City of Clarksville, Iowa:

A. To amend the City Clerk salary to \$43,262.00.

B. Stipulation that the City Clerk goes from a family to a single plan for health insurance coverage, which results in a savings to the City.

C. This resolution shall be effective March 1, 2014.
