

**CITY OF CLARKSVILLE  
CITY COUNCIL BUSINESS MEETING  
JANUARY 9, 2014**

David Kelm took the Oath of Office as Mayor of the City of Clarksville, Iowa, and Bond of Mayor Oath - administered by City Clerk Larry Betts.

Mayor Kelm administered the Oath of Office to Cathy Cummings, Diane Renning, and Travis Sterken as Council members; and the Oath to Police Chief Daniel Cummings and Fire Chief Jon Myers.

The Clarksville City Council met in regular session January 9, 2014, in the Council Chambers of City Hall at 6:00 p.m. with Mayor David Kelm in the chair and Council members Cathy Cummings, Jeff Kolb, Diane Renning, Travis Sterken, and Val Swinton present.
