

## Spring 2015 Residential Tree Program – Clarksville Region

MidAmerican Energy Company customers in Iowa are eligible to purchase trees for \$30 each (*with the remaining cost funded through a grant from MidAmerican Energy*). Purchase is initially limited to two trees per household to ensure that all customers have the opportunity to participate. Advanced purchase is required. In the event that additional trees are available on distribution day they will be released for purchase at 9 a.m. on a first-come, first-served basis until all are sold. Trees <u>must</u> be picked up Saturday, May 2, 2015, between 9 and 11 a.m. at Clarksville City Hall, 115 W Superior St. in Clarksville (please pick up trees in parking lot behind city hall). Any trees not picked up by 11 a.m. on distribution day will be considered a donation to the City of Clarksville. **Trees are nonrefundable. Exchanges will not be accepted and plant material is under <u>no</u> warranty and/or guarantee.** 

In exchange for participation in the program, the customer agrees that MidAmerican Energy, Iowa Department of Natural Resources or City of Clarksville shall not be liable, in contract, tort and strict liability or otherwise, for any damages arising out of the administration of this program. **100 TREES AVAILABLE FOR PURCHASE** – Deciduous and ornamental trees are 5-8 feet tall and conifers are 3-4 feet tall. <u>Please consider size at maturity when making your selection(s)</u>. For maximum energy efficiency, shade trees should be planted within 30 feet of the east and west sides and conifers should be planted as windbreaks along the north and west sides of your home. Be sure to call Iowa One Call at **800-292-8989 or 811** to check for utilities at least **48 hours prior to digging/planting**. *(dimensions below indicate size at maturity)* 

- <u>Scarlet Oak</u> (50-70' tall, 40-50' wide)
- <u>Tulip Tree</u> (60-90' tall, 30-50' wide)
  - Kentucky Coffeetree (60-80' tall, 40-55' wide)
- <u>Serviceberry 'Autumn Brilliance'</u> (15-25' tall/wide)
- <u>Redbud</u> (20-30' tall, 25-35' wide)
- <u>White Pine</u> (50-80' tall, 20-40' wide)
