

**CITY OF CLARKSVILLE
CITY COUNCIL BUSINESS MEETING
MAY 4, 2015**

The Clarksville City Council met in regular session May 4, 2015, in the Council Chambers of City Hall at 7:00 p.m. with Mayor David Kelm in the chair and Council members Jeff Kolb, Travis Sterken, and Val Swinton present. Cathy Cummings and Diane Renning absent.

Mayor Kelm opened the Public Hearing at 7:00 p.m., for the purpose of amending the Current City Budget for the fiscal year ending June 30, 2015. There being no oral or written comments for and against the proposed budget amendment, the Mayor declared the hearing closed.

Motion Kolb, Swinton, to adopt Resolution 15-572: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLARKSVILLE, IOWA, AMENDING THE CURRENT BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2015, AS AMENDED LAST ON MARCH 3, 2014.
