

**CITY OF CLARKSVILLE
CITY COUNCIL DEPARTMENT MEETING
JANUARY 18, 2016**

The Clarksville City Council met in regular session January 18, 2016, in the Council Chambers at 7:00 p.m. with Mayor Val Swinton in the chair and Council members Roger Doty, Jeff Kolb, Diane Renning, Kenneth Smith, and Travis Sterken present.

The following Department Heads were in attendance: Kristen Clark, Library Director; Matt Kampman, Maintenance Superintendent; Jon Myers, Fire Chief; and Larry Betts, Financial Administration.

Mayor Swinton entertained that this meeting was a time for Department Heads to submit requests to the Council for the 2016/17 City Budget.

Motion Renning, Doty, to approve the monthly Public Library reports submitted by Kristen Clark.

Mayor Val Swinton made the following appointment of Barry Mackey as Police Chief for the City of Clarksville, Iowa as per Municipal Code of Ordinance 30.06.

Motion Sterken, Smith, to adopt Resolution 16-590: A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF CLARKSVILLE, IOWA FOR THE APPOINTMENT OF POLICE CHIEF.

WHEREAS, the Police Chief position for the City of Clarksville has been vacant upon the resignation of the former Police Chief; and

WHEREAS, the Clarksville Municipal Code of Ordinance 30.06 provides that the Mayor shall appoint and dismiss the Police Chief, subject to the consent of a majority of the Council; and

WHEREAS, the City of Clarksville has previously engaged in a Police Chief search and, at the time of the previous search, had narrowed the candidates.

THEREFORE, BE IT RESOLVED that the Mayor appoints Barry Mackey, Police Chief, subject to the following conditions:

1. That Police Chief Mackey will meet with the Mayor twice a month to review all responsibilities and requirements set forth in Chapter 30 of the Code of Ordinances.
2. That Police Chief Mackey will be subject to his first annual review 180 days from the date of his appointment.
3. That Police Chief Mackey will provide a report to the Council, prior to the City Council meeting scheduled for Department Heads each month.

This appointment shall be effective February 1, 2016.


