

**CITY OF CLARKSVILLE  
CITY COUNCIL BUSINESS MEETING  
FEBRUARY 1, 2016**

The Clarksville City Council met in regular session February 1, 2016, in the Council Chambers of City Hall at 5:30 p.m. with Mayor Val Swinton in the chair and Council members Roger Doty, Diane Renning, Kenneth Smith, and Travis Sterken present, Jeff Kolb absent.

Motion, to approve and adopt the items contained on the Consent Agenda: Motion to approve minutes (January 4, 2016 and January 18, 2016).

Mayor Swinton administered the Oath of Office to Barry Mackey as Police Chief for the City of Clarksville.

Council member Diane Renning made the following appointment of Lori Peterson as Deputy City Clerk for the City of Clarksville, Iowa, as per Municipal Code of Ordinance 18.01.

Motion Renning, Doty, to adopt Resolution 16-591: A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF CLARKSVILLE, IOWA FOR THE APPOINTMENT OF DEPUTY CITY CLERK.

WHEREAS, a Deputy City Clerk – FT position be created for advancement to City Clerk after training completed; and

WHEREAS, the Clarksville Municipal Code of Ordinance 18.01 provides that the Council shall appoint by majority vote a City Clerk to serve at the discretion of the Council; and

WHEREAS, the City of Clarksville has previously engaged in a Deputy City Clerk search and, at the time of the previous search, had narrowed the candidates.

THEREFORE, BE IT RESOLVED that the Council appoints Lori Peterson.

This appointment shall be effective February 1, 2016.
