

**CITY OF CLARKSVILLE
CITY COUNCIL DEPARTMENT MEETING
MAY 16, 2016**

The Clarksville City Council met in regular session May 16, 2016, in the Council Chambers at 7:00 p.m. with Mayor Val Swinton in the chair and Council members Roger Doty, Jeff Kolb, Diane Renning, Kenneth Smith, and Travis Sterken present.
