

**CITY OF CLARKSVILLE  
CITY COUNCIL BUSINESS MEETING  
May 4, 2020**

The Clarksville City Council met in regular session via Zoom May 4, 2020, in the City Council Chambers at 6:30 p.m. with Mayor Kenneth Smith in the chair and Council Members Roger Doty, Todd Fails, Brock Lodge, Diane Renning, and Larry Voigts present.
