**CITY COUNCIL DEPARTMENT MEETING**  
**September 19, 2022**

The Clarksville City Council met in regular session on September 19, 2022 the City Council Chambers at 6:30 p.m. with Mayor Michael Grantham presiding and Council Members Roger Doty, Wendy Brooks, Jennifer Kielman, and Brock Lodge present with Taran Sherburne, by phone. The following Department Heads and employees were in attendance: Molly Bohlen, City Clerk, Kristen Clark, librarian, and Barry Mackey, Police Chief. Members of the public present were: Rhonda Landrum and Chris White.

Wendy Brooks asked for the ordinances to be added to agenda on the October 3<sup>rd</sup> meeting.

Mayor Topics: Employee reviews were discussed. Molly Bohlen, City Clerk review was discussed.
